1. To catch-up missed content and ensure students are ready for assessment in 2021 and 2022

The EEF states: 'There is extensive evidence supporting the impact of high quality one to one and small group tuition as a catch-up strategy.' We are using in-house and online companies to give our students some individualised and group catch up time.

2. To support students' wellbeing and promote attendance.

Attendance and motivation are, undoubtably, going to be difficult during a pandemic and Ofsted are clear on the impact on students: 'Despite the broadly positive picture, several concerns have emerged: some pupils' concentration or their mental and physical stamina have reduced'

3. To accurately assess students' gaps and create target grades for Y7

Due to the lack of SATs for the current Y7 and missed learning from March to July 2020 for Y8 to 11, we need to spend time assessing students appropriately.

Assessing Y8 to Y11	Mock exams and in-class assessment for Y8 to Y11 to see learning missed.	Free

4. To provide key resources to students, including technology, to support remote learning.

As the EEF states: 'As all pupils return to schools, technology could also be valuable; for example, by facilitating access to online tuition or support. Some schools might find it helpful to invest in additional technology, either by providing pupils with devices or improving the facilities available in school.'
